



### **1. What is a 1098-T form?**

The 1098-T form is a document which contains information to assist the IRS and you in determining if you are eligible to claim educational related tax credits such as the American Opportunity (Hope Credit extended) and Lifetime Learning Credits. ### **2. Where do I get my 1098T form?**

Carrington College has partnered with ECSI, to distribute the 1098T forms to students. If you submitted your consent in advance, you will get an email when the data is available. If consent was not received for electronic delivery, then the form will be mailed. Either by email or mail, the required deadline is that the form be dated on or before 01/31/2024.

### **3. Was a copy of the 1098-T form also sent to the IRS?**

Yes. The Taxpayer Relief Act of 1997 (TRA97) required Carrington College to send a copy of the 1098- T form to the IRS for any student with qualified tuition and related expenses for the previous calendar year. These will be sent in March as required and again if there are any updates or corrections to your 1098-T.

### **4. Where can I find 1098-T form?**

To access your 1098-T statement online, you will need:

- First and Last Name
- Social Security Number
- Student's Zip Code (provided by Carrington as of 01/09/2024)

To access your 1098-T form from the Heartland ECSI website now, you can follow these steps:

1. Go to <https://heartland.ecsi.net/index.main.html#/access/lookup>
2. Select "I need my 1098-T Tuition tax statement", click Go>>
3. Search school name using "Carrington"
4. Select: "The School Name for your campus – see below or the email sent 1/23/2024"
5. Click Submit
6. Complete the form and Click Continue
7. On the right side, click on "View Details" to see some information.
8. Click View/Print Statement to see the complete form.
